We are pleased to present a proposal for the complete abatement and demolition of the existing church facility in the amount of **Three Hundred Eighty-Five Thousand Three Hundred Twenty-Nine Dollars and No Cents (\$385,329.00)**. This estimate is based on the demolition plans issued by EOA on October 22, 2021. The masonry and millwork components of the building to be salvaged in included in the cost of the proposal.

Currently the project schedule and general conditions are based on a thirteen (13) week duration. This schedule assumes a timely notice to proceed as well as issuance of a demolition and grading permit by Metro Codes. Currently, a demolition permit is under review by Metro Codes. We have learned based on input from demolition firms that Metro Codes will require a grading permit as the building to be removed exceeds 10,000SF. We have reached out to Metro on the steps required to fulfill this requirement.
